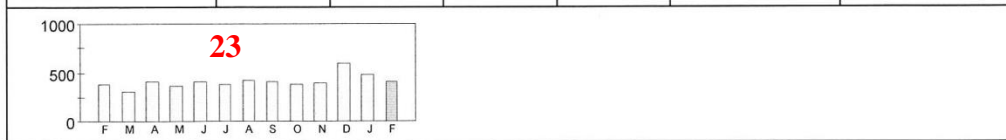

- Contact numbers for electric offices and website.
- Your personal account number.
- Primary name on account.
- The Rate and Class determines how your account will be charged for your energy usage. (see lists below)
- Physical address of your meter. Please notify us if this field needs to be updated.
- From and To Dates are the beginning and ending dates that the meter readings are taken for the current bill.
- Total number of days in current billing period.
- Previous meter reading is what was read last month and present meter reading is what was read this month.
- Multiplier of the meter is normally 1 for residential usage. The kWh from the meter is multiplied by the multiplier. Some larger accounts have a multiplier greater than 1.
- kWh Usage is the total energy usage for the billing period. (present reading - previous reading = current kWh usage)
- Meter number is the serial number on the face of the meter.
- Energy Charge is the cost of kWh used, amount will vary depending on what rate the consumer is classified as.
- System Charge is the cost of providing service, including operations and maintenance of facilities, consumer accounting expenses and administrative costs.
- Fuel Adjustment charge recovers fluctuations in the cost of power from our power suppliers that are not currently collected in our base rate.
- Debt Service Adjustment is a recovery of our interest expenses related to electric loans over and above what is not factored into KCEC's base rate.
- Penalty charge for late payments (past due balance x 1.5%)
- State Tax is the tax you pay to the state where you reside in.
- The amount of your previous bill that is still unpaid.
- Bill comparison of your usage this month, last month and this month last year.
- Total balance owed on your account as of the bill date. (previous balance - payments + current bill = total due)
- Bill Date is the date your bill was processed.
- Due Date is the date your payment is due, after this date your payment will be past due.
- A 13-month graph comparing current usage with previous 12 month usage. (J- Jan.; F- Feb.; M- March; A- April; M- May; J- June; J- July; A- Aug.; S- Sept.; O- Oct.; N- Nov.; D- Dec.)
- This bottom section is your Payment Coupon. Please return this with your payment to ensure that your payment will be applied to your account.
