CEO'S MESSAGE



Friday July 17, 2015 --

Kit Carson Electric Cooperative, Inc. had the official lighting of their \$64.8M American Recovery and Re-Investment Act Fiber-To-The-Home Project. The lighting was celebrated in an official ceremony held at KCEC's headquarters which was attended by State and Local elected officials, several broadband industry representatives and leaders along with the general public. Attendees included District III PRC Commissioner-Valerie Espinoza, Town of Taos Mayor-Daniel Barrone, Taos County Commissioner-Jim Fambro, USDA State Director-Terry Brunner, CoBank Vice President-Jeff Bracker, Fujitsu Network Communications, Inc.'s COO-Doug Moore, NRTC CFO-Terry Gilmore and Utility Telecom Council CEO and President-Connie Durcsak. The event celebrated the culmination of nearly four years of fiber deployment to KCEC's service territory; areas that previously were unserved or underserved. The celebration also gave KCEC's members the opportunity to see first-hand how this valuable tool will enhance the quality of life. There were live gaming demonstrations, a look into smart metering technology, live video conferencing, tele-health/tele-med, and internet video applications.

KCEC CEO-Luis A. Reyes Jr. said "The opportunities this project represents are endless, by enhancing the ability for companies to expand, grow and create greater opportunities in this region and while utilizing a clean and sustainable utility in broadband we find ourselves at the forefront of the technology world. Additionally, we can now offer locals the ability to create economic prosperity with better access to education, economic development and an overall better quality of life".

KCEC's Fiber Initiative supports residents, businesses, communities and anchor institutions. The networks reach is 29 communities comprised of roughly 20,500 households, 3,600 businesses, and 183 critical community institutions as well as two Native American pueblos (Taos and Picuris) within a 2,951 square mile area in Taos, Colfax and Rio Arriba counties in Northern New Mexico. Partnerships with RediNet and Blanca Telecommunications have created paths of redundancy making KCEC's broadband network one of the most robust networks in the State of New Mexico.

In addition to the great celebration, KCEC is excited to announce our prices have become even more competitive. DID YOU KNOW?

Sudden cardiac arrest cause more than 400,000 deaths each year in the U.S. Surprisingly, 9,000 of those are under the age of 18. Less than one-third of cardiac arrest victims receive CPR from someone nearby. Project Heart Start provides a strategy for saving a life, and that life may be your spouse or partner, your child,

The 6th Annual Project Heart Start Day in New Mexico was held on June 20, 2015. A FREE- 40 minute training class for hands-only CPR was conducted throughout the state, including Albuquerque, Rio Rancho, Los Lunas, Los Alamos, Grants, Las Cruces and Questa.

This project was made available to the community of Questa, NM by the Questa Fire Department, in conjunction with several statewide sponsors and our local sponsorship from KCEC. The community members that attended the trainings were trained on recognizing heart attack signs, performing compression CPR, using an AED (Automated External Defibrillator) and saving choking victims. Two classes were made available that day, 7 adults attended the morning session and 8 adults participated in the afternoon session. The trainings were open to all interested New Mexicans from ages 10 to 90 and up.

Our very own KCEC employee, John O. Ortega was one of the coordinators of this project. He also conducts CPR training to all of our KCEC employees. Every employee at Kit Carson Electric has completed the CPR Certification, and continues to uphold their Certification by attending the proper trainings every two years.
