PRC Suspends Tri-State Electric Rate Increase and Rate Redesign

Kit Carson Electric Cooperative, Inc. (KCEC), along with two other New Mexico electric cooperatives, protested a proposed rate increase and rate redesign by Tri-State Generation and Transmission. The New Mexico Public Regulation Commission (PRC) ruled in favor of KCEC at a hearing on December 20, 2012. The changes were due to take place on January 1, 2013. KCEC has fought rate increases by Tri-State for 12 years, but this is the first time other cooperatives have joined in the battle. New Mexico state law requires three cooperatives to protest a rate increase before the PRC can hear the case.

We want to thank those members who took time out of their day to call and e-mail the PRC in support of KCEC's fight

for electric rate stability. Please call the commissioners to thank them for siding with electric consumers in these tough economic times.

The suspension of the increase, the ninth increase by Tri-State since 2000, means KCEC and other New Mexico electric cooperative consumers will not be subject to a 5% increase in rates. According to KCEC CEO Luis Reyes, "The suspension of the rate increase amounts to an annual savings of one million dollars. The rate redesign would have unfairly burdened the business community during already difficult economic times. We are very pleased the commissioners chose to intervene on behalf of our members."

The PRC will assign a hearing examiner and set a hearing schedule. Tri-State has indicated they will seek to stop the suspension through court action.

KCEC Board Appoints David Torres to Fill Trustee Vacancy

The Board of Trustees of Kit Carson Electric Cooperative, Inc. (KCEC) appointed David A. Torres to fill the vacancy left by the retirement of Trustee Francis Cordova. The appointment was made at the board of trustees meeting held on December 27, 2012. He will begin his trustee duties on January 2, 2013 and serve the remainder of Mr. Cordova's term, which was due to expire at the KCEC Annual Meeting in June 2013.

Mr. Torres brings knowledge of cooperative operations having served on the board of Kit Carson Energy, Inc. since 2009. He is currently an International Relief Consultant with Samaritan's Purse, leading assessment and relief teams to natural and man-made disasters in numerous counties. He retired as a Colonel from the United States Air Force in 2006, having served as Senior U.S. Military Advisor to NATO Commander Headquarters in Sarajevo. He has also previously worked for the State of New Mexico as Transportation Programs Division Director for the Department of Transportation and as Taos County Public Works Director. He is married with two children.

KCEC Volunteers Assist in Distribution of Over 1,200 Food Boxes

Current Taos Feeds Taos president Francis Cordova, a recently retired KCEC Trustee, reported Taos Feeds Taos donated more than 1,200 boxes of food to local residents this year. For 27 years this project has thrived due to the generous volunteers from our community. This year donations of \$59,200 were collected for the food purchases. KCEC has actively supported this effort for seven years. That support comes in many forms, including donations from KCEC personnel, assistance with food collection from many of our schools, plus sorting and distributing food. The KCEC Board of Trustees, management and staff are proud to support this worthwhile Taos holiday tradition. According to KCEC CEO Luis Reyes, “The members of the communities served by KCEC have many needs. At the same time, they have a willingness to help their neighbors. The roots run deep here. What has kept those roots growing is demonstrated each year during Taos Feeds Taos. Our Kit Carson Coop family is in a unique position to assist this effort. It is our privilege to be of service to such a worthwhile cause.”

- CEO’s Report: KCEC is meeting financial targets. This means there is no need for a rate increase as of this time.
- There were no major outages during November. This was due to continual upgrades being done to the system and the vigilance of KCEC operations personnel.
- The KCEC board of trustees approved a resolution in support of Holy Cross Hospital and commending them for their outstanding service to our community.
- An update was given on the Tri-State rate increase protest to the PRC (see related story).
